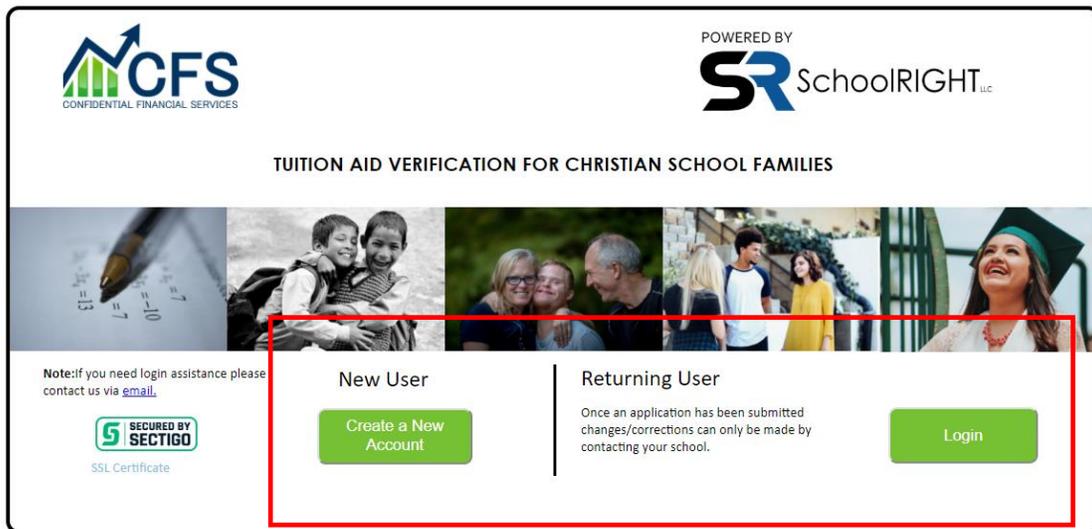
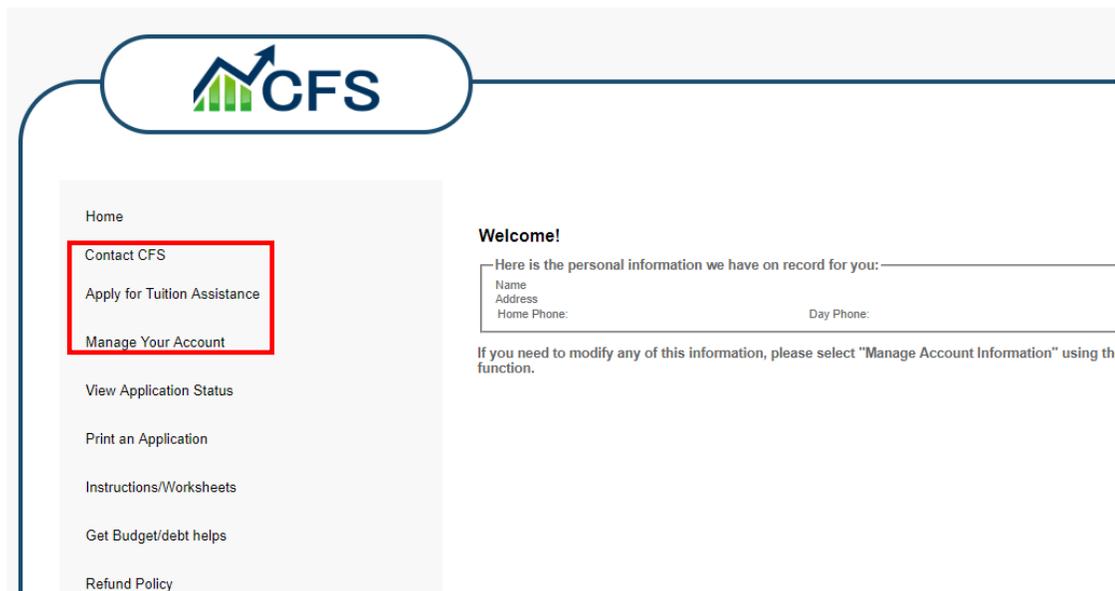


Instructions for Completing the Confidential Financial Services Online Application:

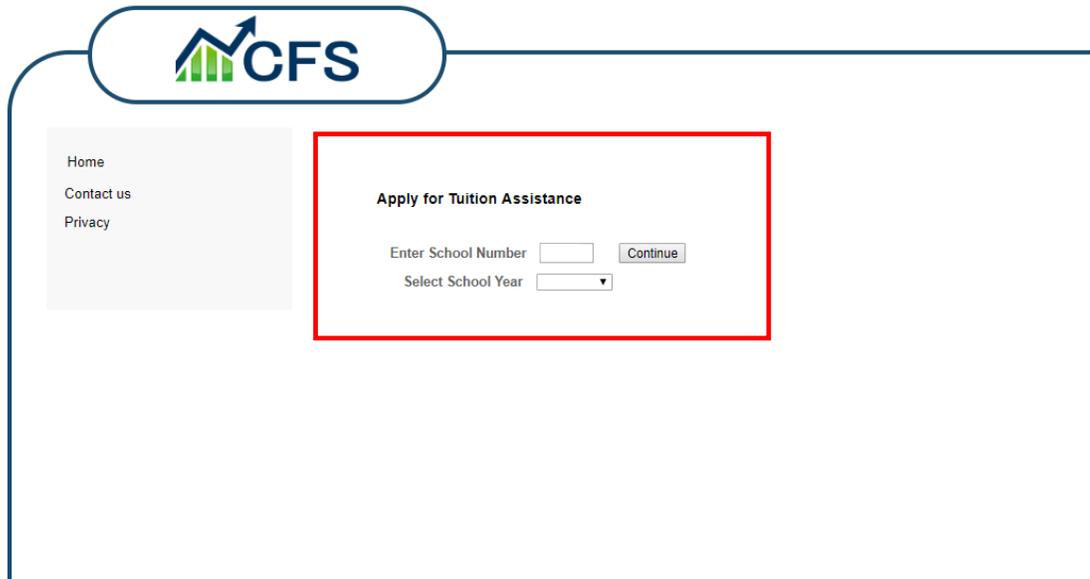
Step 1: Go to www.cfslogin.com and either login to your account or create a new account if you do not yet have one.



Step 2: Once logged in, select "Apply for Tuition Assistance" from the options on the left.

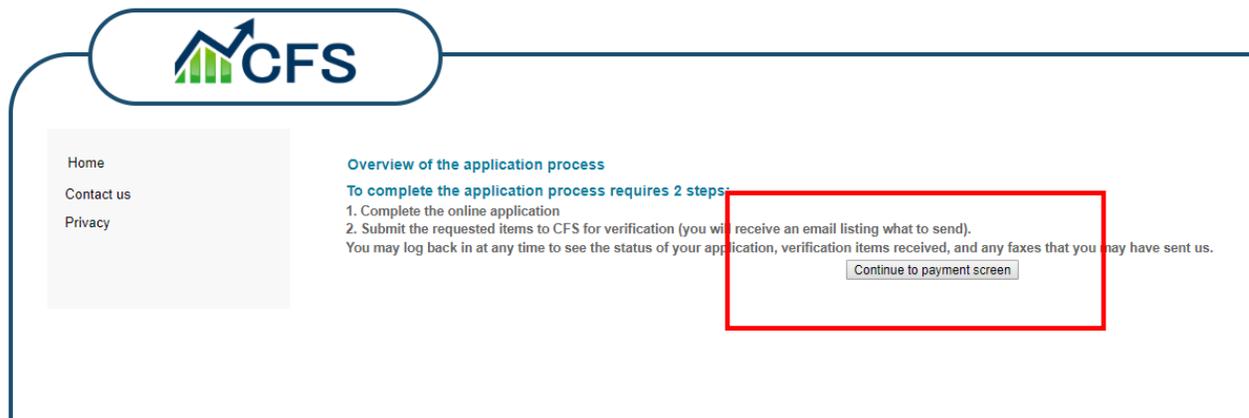


Step 3: Enter your school number (provided by your school) and select the school year for which you are applying

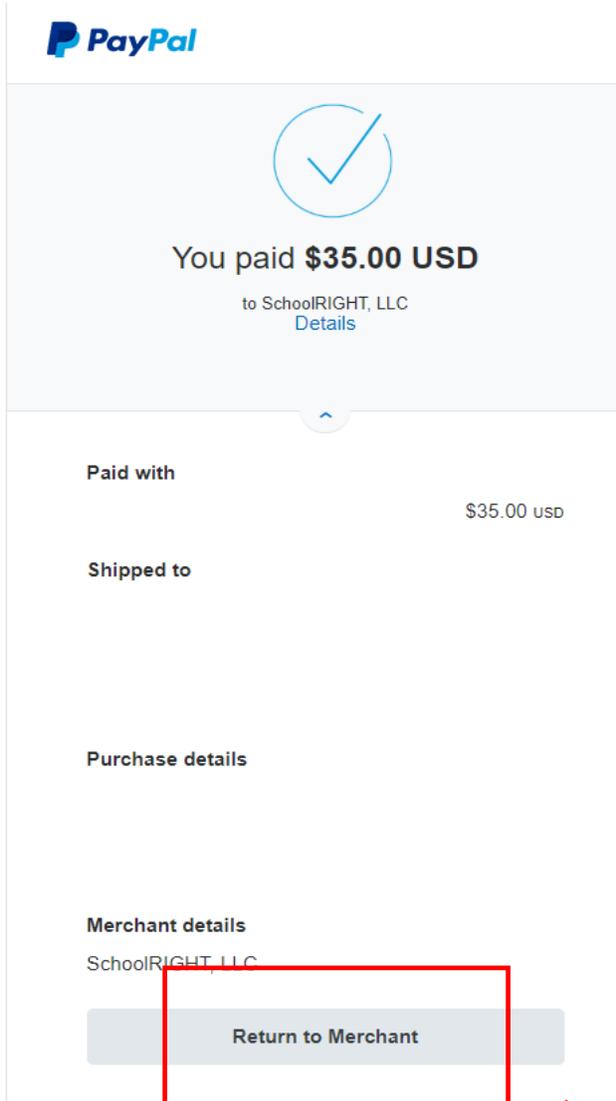
Step 4: Follow the prompts to pay through PayPal. You do not need a PayPal account, just a credit or debit card.

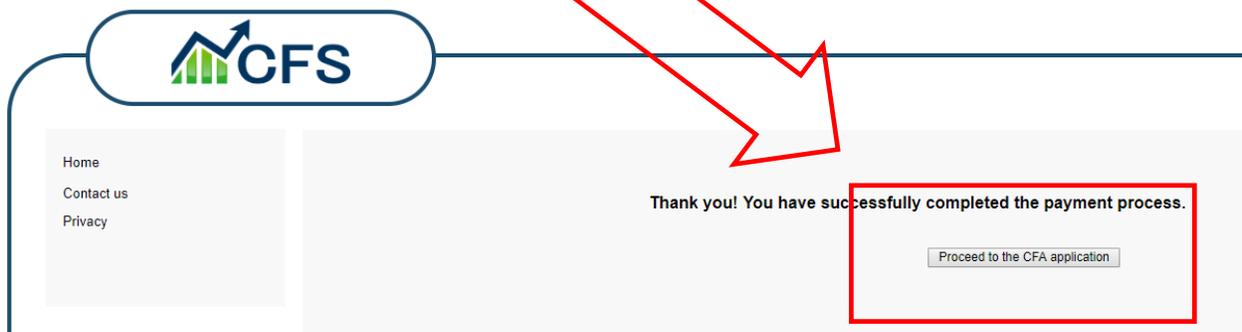
Step 5: Once you make your payment, make sure to follow the prompts back to Confidential Financial Service's website, where your application will be opened for you to fill out.
